IN 1991, LSCRF AFFILIATED WITH NORTHWESTERN MEMORIAL HOSPITAL WITH AN INITIAL PLEDGE OF \$1 MILLION TO ESTABLISH THE LYNN SAGE COMPREHENSIVE BREAST CENTER. TODAY, THE LYNN SAGE COMPREHENSIVE BREAST CENTER IS THE LARGEST PROGRAM OF ITS KIND IN THE STATE OF ILLINOIS AND THE MIDWEST, WITH AT LEAST 70,000 PATIENT VISITS PER YEAR.
