Schedule I, Part I, Line 2 - In June 2020, the Foundation entered into an agreement with NMF for the naming rights of NMF's principal breast cancer screening and diagnostic center, currently known as Lynn Sage Comprehensive Breast Center (the Center). In exchange for the naming rights, the Foundation has committed to support NMF, its other Affiliates, and Northwestern University's Feinberg School of Medicine, in the amount of the larger of \$300,000 or 55% of the total gifts, grants, and contributions the Foundation raises each year, for a period of twenty-five years commencing January 1, 2020. This 55% is evaluated for review once every five years and once met, that period is no longer part of the calculation. After this period the Foundation has extension rights and first refusal rights to the naming of the Center, should another offer be made at that time to NMF by a third party, in which case the Foundation can retain the rights by meeting the terms of that offer. The entire period is divided into five consecutive five-year review periods. No later than three months after each review period, the Foundation has to demonstrate that it met these and other conditions specified in the agreement in order to retain the naming rights of the Center. The 55% primary support clause ceases to apply if the aggregate support during the 25-year period reaches \$20,000,000.
